General Rules:	<ol style="list-style-type: none"> 1. All participants need to be registered on our database. Tests are published on the website. Membership Registration on www.cowboyydressagesa.co.za 2. Payments of all entries must reflect SURNAME on the bank/money transfers and cash deposits. 3. Entries will be done on a "first come first serve" basis – the Tour Gatherings has LIMITED ENTRIES PER DAY! 4. Late entries will be refused and participation on the day will be refused to riders with outstanding entry fee payments. 5. Payments into wrong bank accounts will be seen as Non-Payments. 6. ENTRY FEES ARE PAYABLE BEFORE THE CLOSING DATE OF ENTRY. 7. Should a judge disqualify a rider due to misconduct, such rider will lose their placing on the day. 8. Please make sure you have read Cowboy Dressage® World South Africa Rules and Regulations together with the CDW General Rules – www.cowboyydressagesa.co.za 9. Please make sure that you have read and understand the CDWSA Pledge which includes our code of conduct. 10. The show organisers reserve the right to cancel/combine or split classes at their discretion. 11. Please make sure that you comply with the AHS regulations. 12. No under 18 may handle or ride any stallion during a Cowboy Dressage® World South Africa show. 13. ALL <18 MUST wear hard hats. Although strongly suggested to wear hard hats, Adults (over 18) may choose to not wear hard hats when mounted. 14. No cross entries allowed in ridden classes of a horse-rider combination. 15. The Judge's decision is final. 16. It is up to the individual to ensure that their horse/pony has been vaccinated/inoculated and is fit and healthy to compete and does not have to the best of their knowledge any contagious diseases. 17. The competitor undertakes not enter any horse/pony to the show which has an infectious disease, whether notifiable or not, or which horse/pony the competitor could reasonably be expected to know has an infectious disease or may spread such a disease. The competitor shall withdraw such an animal with forfeiture of entry fees. 18. Riders may share a horse in a class if the 4 ridden and 4 Partnership on Ground class rule per day per horse is not exceeded. 19. Buddy horses are allowed next to the arena if well behaved. Riders may be either mounted or standing next to the buddy horse. 20. Ghost score to beat for being placed 1st in classes, will be 65% in virtual shows and 60% for in person shows. 8 and younger and SN classes excluded. 21. Lead Liners only for 8 years and younger and riders with disabilities that need to be on lead, irrespective of their age. 22. Spotters are allowed for assisting the beginner (JoL and JL and SN) riders. 23. There will be NO REFUND on entry fees or any part thereof, after closing date or if the event is postponed or cancelled for any reason whatsoever. 24. Riders with disabilities may compete in all classes at own risk. 25. Please remember that equestrian is a dangerous sport. Make sure you have the necessary personal and public liability insurance in place. and all Covid 19 regulations are adhered too, e.g. wearing of masks when not riding, and social distancing. 26. RIDERS, SPECTATORS AND OFFICIALS all compete, attend, work at the show at own risk. PLEASE DISPLAY A BLUE RIBBON ON THE RIGHT SIDE OF YOUR HORSES BRIDLE.
